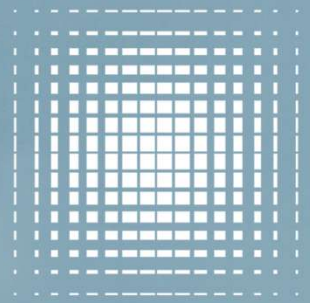

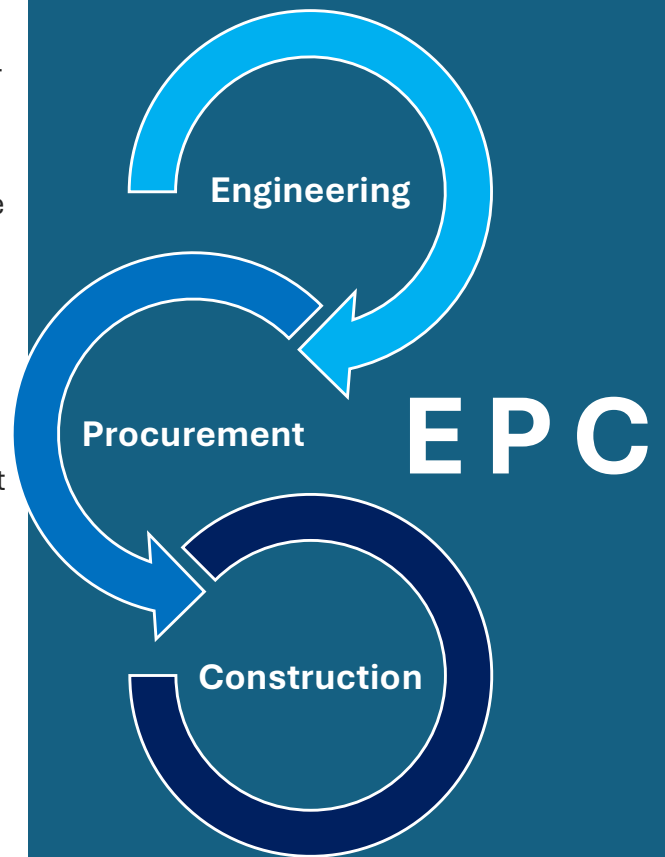

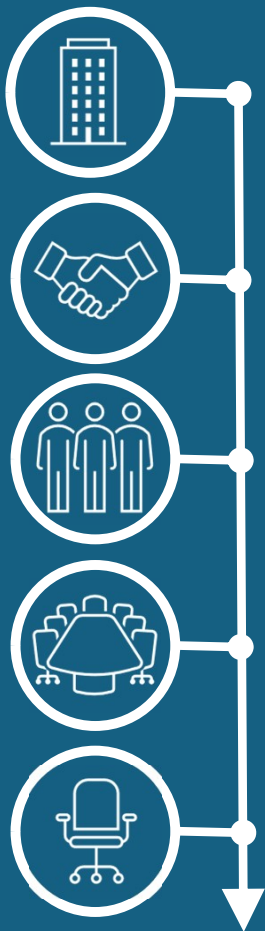

Our Story



INTERCOOL FOOD TECHNOLOGY is a Danish company with a long history with experience of delivering turnkey solutions to the global food industry.

Established in 1958 by Ole and Jørgen Henriksen, the company began by supplying processing plants to Iran and later expanded across the Middle East and North Africa.

In 1981, we were acquired by The Danish Sugar Factories (later Danisco) and became part of Pacilac Danish Turnkey Dairies. It later gained co-ownership from DANISH CROWN and BHJ GROUP, including WOLFKING Denmark.

A management buyout in 1997 led to new ownership, and in 2001, AKP GROUP became the majority shareholder.

As of 2025, AKP GROUP is the sole proprietor, continuing to support innovation and growth.
